Palenque Is Bountiful By David B. Brown

On a northeast slope of a hill where the Maya Lowlands meet the foothills of the Hermounts lies the ancient Maya city of Palenque. This remarkable archaeological site has provided some amazing evidences that identify this site as the Book of Mormon city of Bountiful. One of the first items to present is the Maya city glyph. When inscribing on stela and monuments

the Maya gave each city a unique glyph or emblem by which it is identified. One of the first publications to announce the name of the Palenque city glyph translated it as "bountiful," but apparently it was soon changed to an interpretation of "abundant." Regardless of the semantics the meaning is the same.

The main plaza of the site contains the Palace, the Temple of the Inscriptions and the Temple of the Red Queen. These edifices are large and impressive and it is the Temple of the Inscriptions that houses a tomb where the sarcophagus has etchings all

around that indicates Pakal is a member of one of the ten lost tribes of Israel and that he looks to Corn Incarnate (Christ) as his provider for life eternal.

From the plaza one can turn east to cross a small river to the next level of temples known as the Cross Complex. Located here are three temples; the Temple of the Sun, the Temple of the Cross and the Tem-

Mary Todd Testimony By Neil Steede ©

The June 22, 1940 Saint's Herald published a testimony that I found extremely interesting. That testimony mentions several aspects that support the validity of the experience in spite of it being very unusual. If I had known about this testimony as recently as ten years ago I might have doubted its veracity, but recent developments now indicate that Mary Ellen Todd was given insight that very few have experienced.

In Mary Ellen's experience she was visited by a personage who was "carrying a frame in which were a set of plates." He handed the frame to her which she accepted while in a sitting position on her bed. Interestingly, she describes how the man who brought the plates did not let go of them until they were set upon her lap. She later states that the plates held within the frame were extremely heavy. This detail is supportive of the truth of her testimony, but there is much more ahead.

As Mary looks into the frame she sees the set of plates which have "the appearance of gold" are about one inch thick or a little more and they are round. Round? All of the descriptions of the plates that Joseph Smith Jr. had described them as square and about six to eight inches thick. Therefore, it would seem probable that if this testimony is true, it certainly is not the plates had by Joseph Smith Jr.. Another statement is that the plates are bound on one side by two rings. This experience sounds strange. As these strange comments are more fully explored, several possibilities emerge.



ple of the Foliated Cross. These temples seem to be designed to teach lessons for the newly initiated believer. Crossing over the river is symbolic of the rite of baptism, then on to each temple to learn an aspect of living and balancing the temporal and the spiritual. And each temple has an inscription that is unique to the message given in its teaching.

The Temple of the Sun teaches about the spiritual war between good and evil, and provides the initiate with weapons that will help him win the spiritual war. The Temple of the Cross teaches of the history of the spiritual church. It speaks of the Wisemen that visited Christ after his birth, and the prophecies of Christ from the beginning of time to the coming of Christ and His appearance in the Americas. The Temple of the Foliated Cross teaches about the appearance of Christ after His resurrection and how he provided the transformation for the Three Nephites.

Heading south from the plaza of the Cross Complex one can walk up a narrow path to another series of temples that teach about Christ, but one in particular is most





amazing; Temple XIX. This temple houses the most compelling inscriptions at Palenque. The Throne Room here contains a throne that is larger than any known throne in the Maya world. It is nearly nine feet long and carved from a white stone that is thought to be marble, at the very least a very fine limestone. In this room are two panels that have important bas-relief images that tell an impressive story through symbolism.

The first panel shows how Quetzalcoatl (Christ) offers his gifts to all mankind, but there are those who accept and

there are those who turn away from His offering. Those who accept His offerings are lifted from their burdens and the consequences of their actions are absorbed by Quetzalcoatl through mercy. But those who turn away the gift from Quetzalcoatl are stifled by the burdens they bear and they are left to suffer the demands of justice and the full weight for the consequences of their actions. It is a lesson of the Maya "give and take" theme that is utilized throughout their iconography.

The next panel has a total of seven figures displayed with Quetzalcoatl in the center, three on the right, and three on the left. The three on the left are all facing Quetzalcoatl and have symbols that identify them as the three Wisemen who visited Christ and brought gifts to Him shortly after his birth. Through the use of the symbols provided for each figure and comparing them to stories found in the Book of Mormon we can deduct their names. They are Nephi, his brother Lehi, and Samuel the Lamanite. Perhaps the fact that Samuel traveled all the way around the world to worship the Christ child is one reason why Christ was so adamant that Samuel's prophecies were added to the records of the Nephites. The body of Quetzalcoatl is leaning toward the three figures on the right as if he is presenting them with something, but he is looking back to honor the three that came to visit Him.

The three on the right are receiving a gift from Christ that appears to be the gift of life. This seems to be the Three Nephites, who also have names that can be associated by deduction through the

Book of Mormon; Nephi, Timothy, and Jonas. The Nephi name is almost absolute as it is the same name as one of the figures on the left and we know that Nephi the disciple was the son of Nephi who disappeared and was never heard from again.

This panel again shows a remarkable Maya concept of "give and take" in that Christ received gifts from three spiritual leaders who traveled half a world to find Him, therefore Christ gave the gift of life-to-serve to three disciples in the Americas. And this panel displays this event very profoundly.

One last thing to mention is the huge throne that is in Temple XIX. No one knows how long Christ was in the Americas teaching before He ascended back to the Father, but was it long enough for this temple to be built and for Christ to sit upon this throne? Who knows? But, it certainly would be a personal experience to stand in this room and read the panels

and know that Christ was here. Did Christ sit on a throne in the Americas? There is a throne located in a strange place at Palenque; it is in one of the lower passages of the Palace. Is this the throne upon which Christ sat when He came to Bountiful? Perhaps some day we will know for sure, but for now we can only speculate.

Mary Todd Testimony Continued

In recent years artifacts of supposed Jaredite origin have been located and are now under study. Those artifacts date from Jaredite times and consist of several stone discs. Those discs have several interesting parallels to Mary Ellen's visual experience. Though there are fourteen partial discs of different sizes, the average diameter is ten to eleven inches as described some forty years before they were found. Even the fact that these stones are discs would seem to be significant. While the discs referred to are of stone and about one-quarter inch thick, they are plated with pyrite on the reverse side. The obverse sides are carved.

The carvings on these discs are not in a script, but are bas-relief illustrations. Seemingly all of them are referring to different aspects of Quetzalcoatl. Their messages have not yet been fully deciphered and this is why there is still no publication over these objects.

Having seen these objects before reading Mary Ellen's testimony has made that testimony more meaningful to me. This is because not only are these inscribed objects discs, but they also have Fool's Gold (pyrite) covering the reverse sides which give them the "appearance of gold." And there is more. Each of these discs is perforated by four holes on one edge. This is very similar to Mary Ellen's vision. Is it possible that the discs were made this way so as to replicate original plates?

In my book <u>Book of Mormon Archaeology</u>; Artifact by Artifact I theorize that Jaredite plates had no binding rings, and while I still believe this to be basically true it is still possible that some were bound. Once the Jaredites came into contact with the Nephites the innovation of binding rings could well have been adopted. However, this may not be the specific case seen by Mary Ellen. Though the following is mere speculation it seems to be a valid possibility to put forward at this time.

If one supposes that the personage visiting Mary Ellen was Moroni, then it is likely that the plates that she saw were Ether's twenty-four gold plates that were translated by Moroni. I believe that the title of those plates were the *twenty-four* gold plates because they were not bound

by rings, but were loose. Therefore by putting the number twenty-four into the title one could count them to make sure that one had a complete set. Moroni being accustomed to bound plates may have added the two rings for his convenience. Now I do suspect that it was Moroni that Mary Ellen envisioned as opposed to Ether. The reason for this was the physical description of the personage.

Being a personage described as wide, muscular, and with a large head is very interesting. This sounds particularly Maya in description. Especially the wideface and large head is even fodder for Mexican comedians even today (i.e. the late Loco Valdez). The reference is commonly made to the *Cabezon Yucatecos*— "big-headed" people from the Yucatan peninsula of Mexico. I cannot believe that aspect of Mary Ellen's description would include these details as coincidence.

It will be most interesting to see what is found in the future. By the way, I expect those plates to have a blank plate about halfway through as Mary Ellen described. Mary Ellen, I trust you.

The Importance of Testimony By Tim Brown

I have a testimony of the Book of Mormon. That's great for me but what does it do for you or anyone else? It can reinforce a testimony that you already have or it can encourage you to seek your own, but it cannot replace or act as a substitute for your personal experience. You

can accept someone else's testimony on faith and use it as a bridge to move you forward in your faith journey, yet too many people have relied on someone else's testimony without seeking their own and have since lost their way in regard to the Restoration movement.

I was afforded the opportunity of time to read the Book of Mormon during the summer of 1972 while riding to and from work with my employer Lynn Cox. I've never doubted the divinity of the stories surrounding the Book of Mormon, but I had never sat down and read it from cover to cover until then. My testimony is very simple,

not really the way I asked for it. I had read of angels appearing to some and others hearing an audible voice declaring the truth of the book. These types of grand manifestations were what I wanted. I thought I was entitled to tell God how to reveal Himself. In James 1:1-5 we read:

You can accept someone else's testimony on faith and use it as a bridge to move you forward in your faith journey, yet too many people have relied on someone else's testimony without seeking their own and have since lost their way in regard to the Restoration movement.

"James, a servant of God and of the Lord Jesus Christ, to the twelve tribes which are scattered abroad, greeting. My brethren, count it all joy when ye fall into many afflictions; Knowing this, that the trying of your faith worketh patience. But let patience have its perfect work, that ye may be perfect and entire, wanting nothing. If any of you lack wisdom, let him ask of God, that giveth to all men liberally, and upbraideth not; and it shall be given him." If God is no respecter of persons and if He did that for others He

should do that for me.

God is a great teacher. He gives us what we need not necessarily what we want. I needed patience and humility. I didn't receive the grand lightning and thunder testimony. What I did receive was much better for me. Countless times as I was reading the Book of Mormon the Spirit would rest on me and tears would begin to flow. It wasn't a very macho thing to be in construc-

tion and have your boss look over and see you crying. How can you explain your tears? It was a feeling that touched the depth of my soul and I felt totally unworthy, and yet at the same time I was given to understand that the God of heaven and

earth loved me and accepted me for who I am; a part of His creation. No lightning or thunder, no angels or visions, no voice from heaven, just the quiet assurance that He was fulfilling the promise given in Moroni 10:4-5 "And when ve shall have received these things, I would exhort you that ve would ask God, the eternal Father, in the name of Christ, if these things are not true; and if ye shall ask with a sincere heart, with real intent, having faith in Christ, He will manifest the truth of it unto you, by the power of the Holy Ghost; and by the power of the Holy Ghost, ye may know the truth of all things.

When you have your own testimony from God through the Holy Spirit nothing else matters. The voices of the world may talk about the Solomon Spalding book, or the Sidney Rigdon influence, or the 19th century writings of a man with an overactive imagination (although "inspired"). There are conflicting stories about how the record was translated; with the interpreters behind a curtained wall, or a stone in a hat, or a peep stone; it matters not to me. Those voices just melt away into irrelevance. I can neither confirm nor deny these stories because I wasn't there and neither was anyone else now living. But I know the book is true because of the presence of the Holy Spirit. Thousands upon thousands have had similar experiences as mine. Whether any church associated with the Book of Mormon is teaching the true gospel of Christ may be questioned, but the book itself cannot. It's one of God's promised revelations in these latter days as told by Ezekiel in the 37th chapter verses 15-20: "The word of the Lord came again unto me, saying, Moreover, thou son of man, take thee one stick and write upon it, for Judah, and for the children of Israel his companions; then take another stick, and write upon it, for Joseph, the stick of Ephraim, and for all the house of Israel his companions; And join them one to another into one stick; and they shall become one in thine hand. And when the children of thy people shall speak unto thee, saying, Wilt thou not show us what thou meanest by these? Say unto them, Thus saith the Lord God; Behold, I will take the stick of Joseph, which is in the hand of Ephraim, and the tribes of Israel his fellows, and will put

them with him, even with the stick of Judah, and make them one stick, and they shall be one in mine hand. And the sticks whereon thou writest shall be in thine hand before their eyes."

Upon going to the woods to pray with Oliver Cowdry, David Whitmer and Martin Harris and seeking a testimony to be the three witnesses Joseph Smith wrote: "When immediately afterwards, we heard a voice out of the bright light above us saying, 'These plates have been revealed by the power of God, and they have been translated by the power of God; the translation of them which you have seen is correct and I command you to bear record of what you now see and hear." Church History Vol 1 page 46.

The testimonies of the three and eight witnesses have stood for 180 years. Although they stand as strong as ever they cannot replace our own. The promise given in Moroni 10:4-5 is to all who



seek the truth. Once we have received a witness we are no longer subjected to the voices of doubt. It then becomes our responsibility to pass the torch of truth to others just as the three and eight and thousands of others have done for us. And the reason we need that spirit of testimony is so that our God can move His work forward to complete the promises He has made with Israel in the manner He showed to Ezekiel, from the 37th chapter again, verses 6-14: "Again he said unto me, Prophesy upon these bones, and say unto them, O ye dry bones, hear the word of the Lord. Thus saith the Lord God unto these bones; Behold, I will cause breath to enter into you, and ye shall live; And I will lay sinews upon you, and will bring up flesh upon you, and cover you with skin, and put breath in you, and ye shall live; and ye shall know that I am the Lord. So I prophesied as I was commanded; and as I prophesied, there was a noise, and behold a shaking, and the bones came together, bone to his bone. And when I beheld, lo, the sinews

and the flesh came up upon them, and the skin covered them above, but there was no breath in them. Then said he unto me, Prophesy unto the wind, prophesy, son of man, and say to the wind, Thus saith the Lord God; Come from the four winds, O breath, and breathe upon these slain, that they may live. So I prophesied as he commanded me, and the breath came into them, and they lived, and stood up upon their feet, an exceeding great army. Then he said unto me, Son of man, these bones are the whole house of Israel; behold, they say, Our bones are dried, and our hope is lost; we are cut off for our parts. Therefore prophesy and say unto them, Thus saith the Lord God; Behold, O my people, I will open your graves, and cause you to come up out of your graves, and bring you into the land of Israel. And ye shall know that I am the Lord, when I have opened your graves, O my people, and brought you up out of your graves. And shall put my Spirit in you, and ye shall live, and I shall place you in your own land; then shall ye know that I the Lord have spoken it, and performed it, saith the Lord."

Through the Book of Mormon God is bringing to pass one aspect of Ezekiel's experience. The tribe of Joseph kept many records of their faith journey and Moroni abridged those records to create what we have today in the Book of Mormon. This record is the "bare bones" of their history, but every archaeological evidence that is found begins to develop the sinew and muscle tissues. These evidences still being uncovered provide the connections that are only hinted at in the Book of Mormon and with each piece of added knowledge the mystery of these ancient people begins to take form. The key to understanding the Maya has been the Book of Mormon, and the archaeological evidences revealed through that spiritual context is providing the finer understandings of the philosophical tensions within the Maya culture that eventually ripped it apart. The tribe of Joseph is finally being fleshed out and will soon be ready for the command "Thus saith the Lord God; Come from the four winds, O breath, and breathe upon these slain, that they may live. So I prophesied as he commanded me, and the breath came into them, and they lived, and stood up upon their feet, an exceeding great army.'

Mayan Weapons of War

Mayan weapons were made from wood, flint or obsidian stone. These stones were very hard and the sides were chipped away until a thin, sharp, jagged edge remained.

- 1. Arrows- Bows and arrows tipped with stone.
- **2. Knives** -They were made completely of made of stone, both the blade and handle were created by chipping away excess stone.
- **3. Spears** Lances or long spears tipped with stone heads. They could be thrown or used for stabbing.
- **4. Darts** Stone darts were flung at great speed with a throwing stick called an Atlatl by the Aztecs who also used them.
- **5. Sword** They were made of wood, edged with sharp stones. They were called Maquahuitls.
- **6. Clubs** Their handles were made of wood with heavy stone heads. Some were made completely of stone.
- **7. Slings** A leather strap was used to fling stones; much like David used against Goliath in the Bible.
- **8. Axes** They had wooden handles with stone or copper cutting heads, although some have been found made completely of stone.
- **9. Armor** The armor was made from heavy quilted cotton.
- 10. Shield They were made from reeds. (dried plant stalks) Intricate designs were painted on them and often brightly colored bird feathers were attached.
- 11. Helmet These were made of leather, topped with feathers and colorfully painted and might include gold leaf. (thin gold overlay) Their battles consisted of hundreds or even thousands of warriors locked in combat until one side appeared to be winning and the other side surrendered.

Captured enemy warriors were often made slaves, while their leaders were sacrificed.








Flint is a hard mineral quartz, a variety of chert. Flint was used as far back as the stone age for tools and weapons. When struck by a hard object, parts of it flake off and can be shaped into a cutting edge.

Obsidian is a naturally occurring volcanic glass. Obsidian can be chipped like flint and a cutting edge can reach almost molecular thinness, leading to its ancient use for tools and weapons.

The team was able to meet again with old acquaintances in the family of The members of the HCET 2009 Spring Expedition. Moises and with former Mayor Alvaro Rubio. Donated clothing was delivered to the towns of Jalapa de Diaz and to new friends in Piedra Ancha.

On the way to Piedra Ancha the group meet with a stone that punctured the oil pan of the van they were driving and that delayed the visit to our new friends. Once the team was able to reach the town and got reacquainted the team went about surveying Cumorahcita once again, showing the top portion to Neil

Steede who had not yet been to the top. Once at the top Neil's theories were reinforced that this was certainly a pivotal location from which to command a war.

One of the hopes of the trip was to climb to the Mixtec Outlook located on the west end of the valley, but the group was not able to arrange for the climb this year.

But, the individuals who were our contacts for the climb did present for our viewing a remarkable collection of pottery they claimed came from a cave. Neil was very excited to view this and identified it as a collection of Mixtec funerary pottery—he believes it to be from a person of royalty.

An additional find was discovered on the land of Moises. There the team was shown a collection of obsidian and other items that were identified as mostly Nephite. The conclusion drawn here was that this location was a Nephite forward outpost and is helpful in filling in the map of the valley and setting a stage for the layout of the final battle.

This find along with the Mixtec pottery made this a very fruitful venture. The sharing of spiritual moments with our long-distance friends, making new friends, and the gathering of yet more evidence makes this annual venture truly a fulfilling endeavor. Our God is an awesome God!
