1. PROCEEDS NOT GIVEN AWAY AS PRIZES WILL GO TO THE C.C.M.G.F.R..
 2. THE C.C.M.G.F.R. WILL KEEP 20% OF ALL PROCEEDS FROM THE JACKPOT.
 3. DATES OF THE JACKPOT COMPETITION ARE AUGUST 9th AND 10th, 2025
 4. JACKPOT TICKETS MUST BE PURCHASED BEFORE 6:00 A.M. AUGUST 9th, 2025
 5. ALL BOAT MEMBERS MUST HAVE A RODEO TICKET.
 6. THE SPECKLED TROUT JACKPOT WILL BE A **MULTI – FISH JACKPOT**.
 7. A MAXIMUM OF 5 FISH, AS A GROUP, WILL BE WEIGHED IN EACH DAY, **PER BOAT**. THE CUMULATIVE TOTAL WEIGHT OF THE TWO DAY COMPETITION WILL DETERMINE THE WINNER.
 8. ALL FISH CAUGHT MAY QUALIFY FOR OTHER PRIZES IN THE C.C.M.G.F.R.. ANGLERS DESIRING TO ENTER FISH IN REGULAR RODEO AND JACKPOT **MUST WEIGH IN JACKPOT TOTAL FIRST** BEFORE WEIGHING FISH INDIVIDUALLY FOR RODEO PRIZES.
 9. ALL FISH WILL BE CHECKED BY THE OFFICIAL RODEO JUDGE PRIOR TO WEIGHING. ALL SPECKLED TROUT ENTERED IN THE JACKPOT MUST BE **“IN THE SLOT”** (15 INCH MINIMUM LENGTH – 22 INCH MAXIMUM). ALL FISH WEIGHED IN WILL BE MEASURED WITH THE TAIL LAYED "NATURAL," NOT PINCHED. ANY FISH DEEMED NOT ACCEPTABLE BY THE JUDGE WILL BE REJECTED. TAILS DETERMINED TO HAVE BEEN CUT MAY DISQUALIFY THE ANGLER OR TEAM.
 10. ANY PROTEST MUST BE SUBMITTED IN WRITING BEFORE THE CLOSE OF THE WEIGH STATION ON AUGUST 10th, 2025
 11. IN THE EVENT OF A TIE, THE FIRST TWO-DAY CUMULATIVE TOTAL, OF THE TIE, WEIGHED IN WILL BE DETERMINED THE WINNER.
 12. ALL ENTRIES MAY BECOME THE PROPERTY OF THE C.C.M.G.F.R..
 13. PAYMENTS TO THE WINNING TEAM WILL BE MADE TO THE PERSON DESIGNATED BOAT CAPTAIN.
 14. **FISH MUST BE CAUGHT ON A ROD AND REEL.**
 15. OFFICIAL WEIGH STATION IS AT DAUPHIN ISLAND MARINA. WEIGH-IN TIMES ARE THE SAME AS THE C.C.M.G.F.R..
 16. ALL RULES OF THE CONDE CAVALIER MARDI GRAS FISHING RODEO ALSO APPLY.
 17. **THE RODEO JUDGE AND CHAIRMAN WILL DECIDE ANY MATTER NOT SPECIFICALLY COVERED BY THESE RULES. THEIR DECISION IS FINAL. THE C.C.M.G.F.R. RESERVES THE RIGHT TO CHANGE THE FISH SPECIES FOR COMPETITION IN THE EVENT CONSERVATION LAWS PROHIBIT THE DESIGNATED FISH FROM BEING CAUGHT.**
