Earlier this year, famed actor and comedian Mickey Rooney testified before the U.S. Senate Special Committee on Aging. Tearfully and forcefully, the 90 year old actor described years of abuse and exploitation of his wife and him at the hands of his stepson. "For years, I suffered silently, unable to muster the courage to seek the help I knew I needed," said Rooney. This elder person of fame and notoriety, in his words, "felt helpless."

If it can happen to Mickey Rooney, it can happen to anyone and as baby boomers reach elder years, the potential for such cases goes up.

It is imperative that we "SPEAK UP" for seniors! The acronym created and copyrighted by ElderServe Inc., of Louisville, Ky, (and used with permission) speaks to the warning signs of elder abuse:

Sudden changes in behavior or finances

Physical injuries, dehydration or malnourishment

Extreme withdrawal, depression or anxiety

Absence of basic care or necessities

Kept away from others

Unsanitary living conditions

Personal items missing
