The Committee's Responsibilities for the Financial Statements

It is also responsible for safeguarding the assets of the Association and hence for taking reasonable steps for the prevention and detection of fraud, error and non-compliance with laws and regulations.

It is my responsibility to examine the financial statements and state whether particular matters have come to my attention.


Basis of opinion
