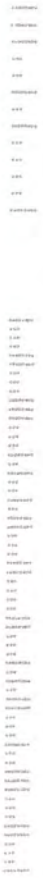


Dear Veronica,
