Dear Joseph:

I went to Columbia on Wednesday afternoon to meet with Attorney Robert Bolchoz. Robert formerly was the number two man in the South Carolina Attorney General's office. He is the attorney I referenced in my fax to your mother when I said there was only one attorney in the state who could do you some good.

I reviewed your file with him and gave him all the insight about you and your case I could. I left your file with him to review. After he reviewed it in detail Wednesday night, he called Mr. Jones at the Attorney General's office Thursday morning and told him that he was handling the hearing on your behalf and asked that it be continued.

It is now set for 10:30 A.M., Thursday, April 15, in Columbia.

Robert tells me that there is a chance he can help you, but only if you show up in Columbia with him. He needs you in his office for last minute preparations at 8:30 A.M. Thursday.

Robert also told me to tell you two things:

1. if you do not show up at the hearing, there is no need to hold it. Mr. Jones will simply find against you and send the paperwork to the Governor's office for extradition.
