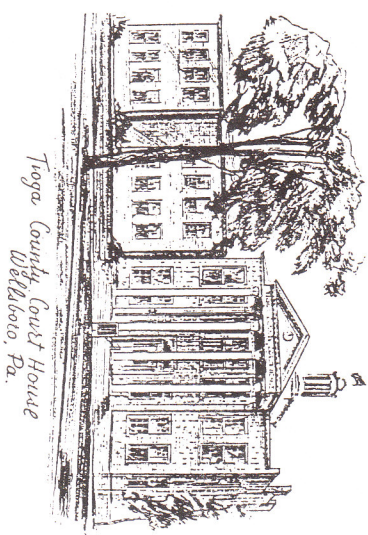

If you have any questions regarding this matter, please contact myself or Chief Stager.

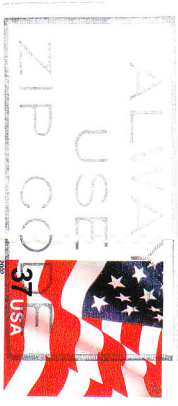

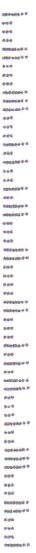
