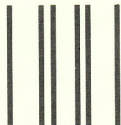

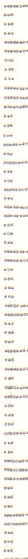

Dear Mr. Snyder:

Upon the receipt of your letter dated March 9, 2001, I retrieved your son's file and reviewed the retainer agreement. That review indicated that there an excess payment of \$1,000. Enclosed please find a check returning that amount.


