- ✓ **Go-live – switching to the new system** and pausing MIM to ensure all processes run smoothly. In case of any severe issues, we can return to MIM and make adjustments before fully transferring to the new solution.
- ✓ **Hypercare** – a standby mode which lasts between 2-4 weeks. Together with the client we monitor how the new solution runs, and if any problems occur, we make adjustments instantly.
