

# **Privacy Policy for Sage Cleaning Services**

This privacy policy describes how Sage Cleaning Services collects, uses, and protects your personal data in accordance with the General Data Protection Regulation (GDPR) and Irish data protection laws.

#### 1. Who We Are

### 2. What Information We Collect

We may collect the following types of personal data:

- Contact Information: Name, address, email address, phone number.
- Service Information: Details of the cleaning services you have requested or received.
- **Payment Information:** Payment card details (processed securely by our payment processor).
- **Website Usage Data:** Information about how you use our website (see our Cookie Policy below).
- **Communications:** Records of any correspondence between you and us.

#### 3. How We Collect Your Information

We collect your information in the following ways:

- **Directly from you:** When you request a quote, book a service, contact us, or provide information through our website.
- **Through our website:** Using cookies and similar technologies (see our Cookie Policy below).
- **From third parties:** In some cases, we may receive your information from third parties, such as referrals or partners, but only when you have given them consent to share it.

# 4. Legal Basis for Processing Your Data

We process your personal data based on the following legal grounds:

- **Contract:** Processing is necessary to fulfill our contractual obligations to you.
- Legitimate Interests: Processing is necessary for our legitimate interests, such as providing and improving our services, and marketing our services (where you have not



objected).

- **Consent:** We process your data based on your consent, such as for certain marketing communications or the use of cookies.
- Legal Obligation: We may process your data to comply with legal obligations.

# 5. How We Use Your Information

We use your information for the following purposes:

- To provide and manage our cleaning services.
- To communicate with you about your bookings, requests, and inquiries.
- To process payments.
- To improve our website and services.
- To send you marketing communications (where you have consented or have not objected).
- To comply with legal obligations.

### 6. Who We Share Your Information With

We may share your information with the following categories of recipients:

- Service providers: Third-party providers who assist us in delivering our services, such as payment processors, IT support, and marketing providers.
- Business partners: Partners with whom we collaborate to provide services.
- Legal authorities: When required by law or to protect our legal rights.

# 7. Data Transfers Outside the EEA

We will not transfer your personal data outside the European Economic Area (EEA) without ensuring that appropriate safeguards are in place, in accordance with GDPR.

# 8. Data Retention

We will retain your personal data for as long as necessary to fulfill the purposes for which it was collected, and as required by applicable laws.

# 9. Your Rights

You have the following rights regarding your personal data:

- **Right to Access:** You can request a copy of the personal data we hold about you.
- **Right to Rectification:** You can ask us to correct inaccurate or incomplete data.
- **Right to Erasure:** You can ask us to delete your data in certain circumstances.
- **Right to Restriction of Processing:** You can ask us to restrict the processing of your data in certain circumstances.
- **Right to Data Portability:** You can request a copy of your data in a portable format.
- **Right to Object:** You can object to the processing of your data based on legitimate interests or for direct marketing purposes.



• **Right to Withdraw Consent:** If we process your data based on your consent, you can withdraw it at any time.
