1. WHAT INFORMATION DO WE COLLECT?

The personal information you disclose to us

We collect personal information that you voluntarily provide to us when registering with us, expressing an interest in obtaining information about us or our products and services, when participating in activities on or otherwise contacting us.

Stripe

On this Website, we have integrated components of Stripe. Stripe is an online payment service provider. Stripe allows payment via various other payment methods, such as credit cards, SOFORT, and so on.

The operating company of Stripe is Stripe Payments Europe, Ltd, 1 Grand Canal Street Lower, Grand Canal Dock, Dublin.

If the data subject chooses one of the online payment methods as the payment option on our website during the registration process, the data of the data subject will be transmitted to Stripe. By doing so, the data subject agrees to the transmission of personal data required for payment processing.

The personal data transmitted to Stripe is usually first name, last name, email address, or other data necessary for payment processing.

The transmission of the data is aimed at payment processing and fraud prevention. The controller will transfer personal data to Stripe, in particular, if a legitimate interest in the transmission is given. This transmission is intended for identity and creditworthiness checks.

Information automatically collected

We automatically collect certain information when you visit, use, or navigate the Site.
