Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	 Our affiliates include insurance companies or agencies with common ownership or corporate names such as Spectrum Planning & Advisory Services Inc., d/b/a Bamboo Wealth Strategies, Sovran Insurance Services, Inc, d/b/a Shorefront Insurance Solutions, Bamboo Insurance Services, Inc., and Greater Pacific Solutions; as well as nonfinancial companies with common ownership and a common corporate identity name such as Spectrum Consulting Group, Inc. 	
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
	 The Firm does not share with non-affiliates so they can market to you. 	
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.	
	The Firm does not jointly market.	

Other Important information

Information for Vermont, California, and Nevada Customers

In response to a Vermont regulation, if we disclose personal information about you to non-affiliated third parties with whom we have joint marketing agreements, we will only disclose your name, address, other contact information, and information about our transactions or experiences with you.

In response to a California law, we automatically treat accounts with California billing addresses as if you do not want to disclose personal information about you to non-affiliated third parties except as permitted by the applicable California law. We will also limit the sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us. Nevada law requires us to disclose that you may request to be placed on our "do not call" list at any time by calling 1-831-759-6300.
