1. The registration is valid upto _____ months prior date of expiry of validity date of registration, with request letter on the firm's letter head along- with Shop & Establishment, Latest Bank Solvency, Financial Rating Certificates, Copies of last 03 years, Balance sheets by a CA, Copies of Renewal certificate from DGQA/DRDO/DGS&D/DGNP/MES/CPRO/ Defence Shipyards/ Defence PSU's (if applicable) and copies of orders executed in the last 03 years at least 90 days before expiry. In case no application for renewal is received by due date, registration will be lapsed and name of your firm will be automatically removed from the list of registered vendors with this yard. .Please apply for renewal of registration at least 03 months prior date of expiry of validity date of registration, with request letter on the firm's letter head along- with Shop & Establishment, Latest Bank Solvency, Financial Rating Certificates, Copies of last 03 years, Balance sheets by a CA, Copies of Renewal certificate from DGQA/DRDO/DGS&D/DGNP/MES/CPRO/ Defence Shipyards/ Defence PSU's (if applicable) and copies of orders executed in the last 03 years at least 90 days before expiry. In case no application for renewal is received by due date, registration will be lapsed and name of your firm will be automatically removed from the list of registered vendors with this yard.
2. The registration renewal is for a period of three years subject to revalidation of Financial Rating for the period of registration.
3. Please note that as a registered firm you are expected to abide by all the terms & conditions of registration. Failure on your part to abide by these Terms & Conditions may result in the cancellation of registration or suitable punitive actions as deemed fit by the yard.
4. **Compliance to Safety & Environment regulations:** As a registered firm you are requested to comply with all the Environment and Safety regulations in force while executing work in the yard. Failure to comply with above regulations may result in punitive action as deemed fit by the yard.
5. Irregularity, relating to security/ gate pass/ unfair trade practice/ syndicate forming/ documents/ test certificates/ substandard quality etc. shall entail deregistration.
6. Holding of Registration Certificate does not entitle firm's representative for an automatic entry into the Dockyard premises. You are to follow the existing procedures for issue of gate pass etc. through the Chief Security Officer of the yard.
7. Registration on the approved vendor list of this yard does not guarantee any relaxation from the Terms and Conditions of the contract or supply orders as amended from time to time, or award of the contracts/ supply order or Tender Enquiry.
8. Changes, if any, in address/location or constitution of the firm should be intimated to this yard, failing which your registration will be cancelled.
9. As a registered firm you are expected to quote competitive rates against Admiral Superintendent's enquiries and secure orders. Also, adherence to delivery schedule/completion dates is necessary. These aspects will be considered at the time of renewal.
10. In case you wish to register for additional items, you are to apply on prescribed Proforma, which can be obtained from this office.
11. If your firm has been registered on the basis of a legally tenable MoU with another firm (sub-vendor), your registration with ND (MBI) for such specific job would be valid only as long as your MoU with the sub-vendor is valid. Further, your firm can only sub-contract the job to the sub-vendor listed in the registration-certificate with which you have a valid MoU.
12. This yard reserves the rights to cancel this registration certificate at any time during the validity period, without assigning any reasons.
