The throwing of any items from motorized or moving vehicles and/or trailers is prohibited. Anyone wishing to distribute candy, fliers or other items must have a person walk within 3 feet alongside the crowd to hand or put items at the feet of spectators.

The Sedro-Woolley Lions Club and the Sedro-Woolley Loggerodeo reserve the right to suspend or bar from the parade at any time any entrant not conforming to the rules and regulations, or refusing to follow the instructions of the police or parade officials.

When 11 yr. old Grace Eyre suffered fatal injuries Friday during a parade, she had just jumped off the back of a pickup truck to distribute candy to spectators. The Nephi girl lost her footing and fell under the flatbed trailer the truck was pulling. Spectators hurried to offer aid, but the crushing injuries would cost Grace her life.

KATC-TV

Reports that witnesses say a child was struck by a vehicle pulling the float after entering the roadway for a piece of candy. KATC says the parade was stopped after the child was hit, and then detoured.

These are incidents we take precautions to prevent by following all the rules set forth in this application.
