Carnegie Library Auction Update



May 14, 10:30 a.m. is the date of the auction that will determine the fate of the former Carnegie Library building at 108 Jefferson Street in Tiffin. According to a March 14, 2019 news release from the Seneca

County Commissioners, the sale has been assigned to Bill Jones of Re/Max Unlimited Results Realty Company. For tours of the building, contact Re/Max at (419)443-7653 or the Seneca County Commissioners' Office (419)447-4550 or **attend the Open Houses on Thursday, April 25, 11 a.m. – 1 p.m. and Saturday, April 27, from 9 a.m. – 11 a.m.** The auction will take place at the building site, and there is no minimum bid price. The Tiffin-Seneca Public Library website tells the history of the acquisition of \$25,000 from philanthropist Andrew Carnegie for construction of the library in 1912. The city was required to budget \$2,500 annually for maintenance of the building. The Carnegie Library served the city and county from 1913 until 1976, when a new library opened down the street. The county then used the building to house the Seneca County Juvenile and Probate Courts until the completion of the multi-jurisdictional Seneca County Justice Center in 2018.

Interestingly, Tiffin is unusual in having two Carnegie Libraries, as Heidelberg University also received a \$25,000 grant in 1905 to build its library, which was not completed until 1912. After the construction of Beeghly Library in 1967, the Carnegie Library was repurposed as Pfleiderer Center and now houses a multi-purpose room/chapel, classrooms, and faculty offices for the humanities.



Fascinating Gardens on Tour


Sunday, June 30, 2019, 12 Noon to 5 pm

Minutes of the Tiffin Historic Trust Annual Meeting, May 31, 2018, 6:30 p.m.

Empire at 138 Restaurant, 138 South Washington St., Tiffin

Board Members Present: John Bing, Karin Brown, Doug Collar, Jackie Fletcher, Mark Levans, Mary Lewis, Joan Martin, Nevin Martin, Vicki Ohl, Nancy Rubenstein, David Selnick, Fred Shelt, Phyllis Watts, Ashley Woodruff

President John Bing welcomed the members and friends to the 6:30 p.m. Annual Dinner Meeting. Don Hutzel gave the invocation.

Following dinner, Mark Levans described the history and revitalization of the Laird Building and introduced the guest panel of speakers, Mitch Felton, Rich Zeis, and Tyler Shuff, who spoke on *The Laird Arcade: How We Got to a Full House*. They described the evolution of the downtown block built by Rezin Shawhan in the 1800s. In the early 1980s Robert and Helen Bollinger developed it into the Laird Arcade, an indoor commercial space, but it was too large of a project for one individual to maintain. Other owners attempted to keep it going. In September 2011, the Tiffin Community Reinvestment Group, with support from four local banks, took on the expense of upgrading the building and have put hundreds of thousands of dollars into improvements. The building is virtually full with commercial and residential tenants. President Bing noted it proved what a team working together can achieve.

Presentation of the Preservation Awards followed the panel discussion. Nevin Martin presented Allen Shultz with the Nevin E.B. Martin Award for his 1840s home at 241 Melmore Street. Doug Collar presented the Historic Preservation Plaques for residential properties to Bryce and Erin Riggs for their 1922 bungalow at 154 Coe Street, to Karl and Amy Kerschner for their 1850s home at 486 South Washington St., and to Andrew and Cindy Kalnow for the renovation of 99-101 Miami Street into upscale apartments. Kalnow spoke of his vision of rehabilitating the area of homes along Frost Parkway.

The Business meeting began at 8:40 p.m. Nevin Martin moved to approve the minutes of the 2017 Annual Meeting, seconded by Doug Collar. The minutes were approved as submitted.

Prior to presenting the budget for 2018-2019, Mary Lewis noted that the endowment fund was moved to the Tiffin Charitable Foundation and that work on the Mansard windows in the Grammes-Brown House would begin in June. Phyllis Watts moved to accept the proposed budget, seconded by Nevin Martin. The membership approved the budget for 2018-2019.

Doug Collar presented the nominations committee report. The candidates for the Board of Trustees for the three-year term ending 2021 were Karin Brown, Vicki Ohl, Fred Shelt, Lisa Swickard and Ashley Woodruff. The membership accepted the nominations as presented. The committee offered the slate of officers to serve July 1, 2018 – June 30, 2019: John Bing as president, Jackie Fletcher as vice-president, Mark Levans as treasurer, and Nancy Rubenstein as secretary. Hearing no nominations from the floor, the members approved the slate of officers by acclamation. The membership approved Doug Collar, Joan Martin and Nancy Rubenstein to serve as the nominations committee for 2018-2019.

Jackie Fletcher moved to adjourn the meeting at 8:50 p.m., seconded by Nevin Martin.

and his Courthouse Square project in Cleveland. A graduate of Oberlin College and Columbia University's Preservation Program, McQuillin first began working for the Ohio Historic Preservation Office, but he has worked on his own as a consultant for more than 34 years. Among his projects are the rehabilitation of Cleveland's *Terminal Tower* and adjacent *Higbee Building* plus numerous projects throughout Cleveland>>s Warehouse District, and much more. His projects and consultations have included 20th century modern commercial buildings; judicial buildings and courthouses; theaters and entertainment centers; public school and college buildings; modern, Victorian and pre-Victorian residences;

Vermillion Institute Founder Steven McQuillin is a preservation consultant based in Hayesville, Ohio, with more than 40 years of experience in the field of historic preservation. He has personally invested in and rehabilitated numerous historic buildings, including his current residence and office in Hayesville, the 1845 historic *Vermillion Institute*, a building that had been abandoned for decades. McQuillin's talk will focus on historic preservation in general and will highlight some of his projects including the Vermillion Institute and Kelley Hardware in Hayesville, the Hedrick House in Mansfield

McQuillin has nominated over one hundred properties and districts to the National Register of Historic Places. At Oberlin, he worked to save several historic buildings and participated in their rehabilitation. As a result of his detailed report on the *Ohio Statehouse* in Columbus, the state did not demolish the historic former *Judiciary Annex* but instead rehabilitated it. Although much of McQuillin's work has been in Ohio, he has also undertaken projects throughout the country.
