MUSCATINE CHRISTIAN ACADEMY STATEMENT OF FAITH

Scripture

We believe the Bible is the only authoritative, infallible, inerrant, inspired Word of God. It consists of the 66 books of the Old and New Testaments and is the supreme and final authority in faith and life. (2 Peter 1:20-21; 2 Timothy 3:16-17)

The Trinity

We believe that there is only one true God, who is infinitely perfect and eternally existent in three distinct persons: Father, Son and Holy Spirit, who are all equal in power and glory. (Matthew 28:19)

God the Father is the first person or the God-Head of the Trinity. He is the Creator, Sustainer and Sovereign of all creation. (Genesis 1:1, Deuteronomy 6:4; John 1:1-3, 14; Isaiah 48:12-16; 1 Corinthians 8:6).

We believe that Jesus Christ, the second person of the Trinity, is the Son of God manifested in the flesh; fully divine and fully man. He lived a sinless life, suffered and died on our behalf, and arose bodily from the grave, ascended to the right hand of the Father, and is coming again in power and glory. He intercedes for us as our High Priest and rules over His Church and the world as Lord and King. (John 10:30; 2 Corinthians 5:21; Mark 16:19; Luke 24:6-7; Revelation 19:11-16; Hebrews 9:26-28; 1 Corinthians 15:2-4; Matthew 1:22-23; John 14:2-3; Hebrews 7:24-27;)

We believe that the Holy Spirit is the third person of the Trinity who regenerates sinners, resides in believers, and convicts them of sin. He enables them to live a Godly life and to use the spiritual gifts He has given them. (John 16:7-15; 1 Corinthians 12-13; Ephesians 1:13-14)

Man

We believe that God created man in his own image - male and female. Mankind sinned and thereby received not only physical death, but also spiritual death, which is eternal separation from God. As a result of the fall, all people are born sinful and in need of salvation, being unable to remedy their lost condition. (Genesis 3:1-24; Romans 3:23; Romans 3:9-20; Psalm 51:5; Romans 5:12)
