Below are the ClarityRx products that have upgraded formulations to enhance therapeutic benefits or increase client satisfaction. A common upgrade you will notice in the product ingredient list is a change from Hyaluronic Acid to Sodium Hyaluronate. Why?

- * Sodium hyaluronate has a smaller molecular weight than hyaluronic acid, which means it can penetrate deeper than hyaluronic acid can.
- * Sodium hyaluronate is more stable and less susceptible to oxidation than hyaluronic acid.
- * While this ingredient is best known for its ability to bind moisture to the skin by increasing hydration, sodium hyaluronate is frequently used in topical pharmaceuticals to aid in the delivery of key or therapeutic ingredients. The addition of this ingredient will boost the effectiveness of the products.

Several of the products listed have had no upgrade in the formulation but the back label will read differently due to the shift from cosmetic to FDA labeling.

Acid Correctors (Fix It, Brighten It, Restore It) - Retail Only

Potassium Hydroxide was added to the three acid correctors to buffer the pH and ensure reduced irritation and increase compliance. This change happened 2 years ago to accommodate Canadian distribution.

Cleanse Daily™ Vitamin-Infused Cleanser - Retail ONLY (Pro and Travel due in Nov.)

Re-Launched as NEW & IMPROVED (June 2023, currently for retail only) Bolstered with hydrating Sodium Hyaluronate, and even more beneficial plant extracts to nourish and calm skin.

Take It Off™ Gentle Make-Up Remover - Retail & Pro

While there has been no change in the formula, ClarityRx has refined the preservative system making this formula even more mild.

Hyaluronic Acid upgraded to Hydrolyzed Sodium Hyaluronate for even greater skin benefits. We removed a few more stimulating ingredients and replaced them with Saccharomyces Lysate Extract, Glycerin and Disodium Phosphate.

Beneficial plant extracts Added: Melia Azadirachta Leaf Extract, Melia Azadirachta Flower Extract, Corallina Officinalis Extract, Coccinia Indica Fruit Extract, Solanum Melongena (Eggplant) Fruit Extract, Aloe Barbadensis Flower Extract, Ocimum Sanctum Leaf Extract, Ocimum Basilicum (Basil) Flower/Leaf Extract, Curcuma Longa (Turmeric) Root Extract to further calm sensitized skin.
