Personal achievements - ben and Emma gave an overview of all the races Striders had entered, too many to mention in the minutes!!

The year ahead - LT said the next phase was that we wanted to evolve the offer at the club as - c25k to bunny hop and beyond. This year the club is actively involved with the organisation of the Bunny Hop race which would become a fully fledged Street Striders event as Shapwick runners wished to stand down.
