# **Presidents Reports**

President Blevins discusses the Cochlear Implant letter that was sent to the Governor Cooper:

Dear Governor Cooper,

On February 25th, 2022, your office announced a proclamation that February 25th be the Cochlear Implant Day for North Carolina. We, the North Carolina Association for the Deaf (NCAD), believe this does not represent the majority of the views of the deaf and hard-of-hearing community as an effective intervention for improving the quality of communication and life for us.

Cochlear implant research inaccurately and unfairly presents to the professional community an effective medical intervention for addressing communication access and language development for deaf and hard-of-hearing children. Many children with cochlear implants continue to struggle with spoken language due to not having full access to communication with peers who use spoken English.

A cochlear implant is an expensive medical device that requires evasive surgery requiring years of therapy to learn to hear with it. In addition, it does not guarantee that a child will be successful with it even if they follow a strict plan. NCAD feels we should be celebrating people, not a medical device with a long history of uncertainties. We are not a group of people who believe we need to be fixed but have the desire to see the rest community embrace our language, American Sign Language, and the rich culture and history of our people.

As a side note, the contributing members of the groups named in support of this proclamation (NC EHDI and NC DSDHH) were unaware of or did not participate in making such a proposal for Cochlear Implant Day. No other Associations for the Deaf were consulted such as Deaf Seniors of NC, NC Black Deaf Advocates and NC DeafBlind Associates.

In conclusion, we are against the implementation of celebrating Cochlear Implant Day in North Carolina as the implant is merely a medical tool. We would like to see it removed.

# **AGENDA TOPIC: NC DSDHH Report**

Ashley Benton represents NC DSDHH at NCAD Board meetings. For today's board meeting, the Director of NC DSDHH, Jan Withers, has chosen to come in her place.

- I. Workshop/Training Descriptions
  - a. NC DSDHH is in the progress of creating a webpage of workshop/training that are available to the community by adding workshop descriptions
  - b. The website is experiencing some challenges as it does not have the ability to insert videos and documents where consumers can download and print copies
- II. Health Care
  - a. The national health care equity survey focuses on race and ethnicity, showing that marginalized communities are not experiencing equal access to health care
  - b. There is 400+ nursing homes statewide with only 7 regional resource centers under NC DSDHH to serve upon requests.
- III. Interpreting service is challenged/limited in certain areas
  - a. Safe Housing for Battered Women
  - b. Domestic Violence Shelters
  - c. DMV (interpreting service is needed for deaf/hoh consumers)
  - d. Teletherapy (research is being on how to add captioning and how to implement interpreting service during consultation)

### AGENDA TOPIC: NC DSDHH Report

Secretary Marshall reports a concern that NC Beginnings and NC EHDI are not offering and will not offer paid sign language classes (including online courses) for families with deaf children.

# AGENDA TOPIC: NC Mental Health Council for the Deaf and Hard of Hearing

Representative Nelson has served on NC Mental Health Council for the Deaf and Hard of Hearing for the past six years. When NC MHCDHH Director, Brad Trotter, retired (shortly before the COVID pandemic), there have been no council meetings for nearly two years until August 12, 2022.
