# AGENDA TOPIC: HB11 - Hugh Blackwell, NC House of Representatives

President Lupo plans to have Mr. Hugh Blackwell give a talk in August as he is the main author of HB 11 to explain more about the bill to the public.

House Bill 11 affects all three schools: ENCSD, NCSD & GMS – the Eastern North Carolina School for the Deaf, the North Carolina School for the Deaf, and the Governor Morehead School for the Blind. HB11 would change the governance structure for three state-run schools.

Currently, the State Board of Education and the N.C. Department of Public Instruction oversees the three schools. The bill changes the governance structure where the schools will be operated by three local boards with two appointments by the House Speaker, two by the Senate leader, and one by the State Board of Education. It takes the power away from Raleigh and disperse it locally.
