AGENDA TOPIC: 2025 NCAD Conference

Secretary Marshall discusses the benefits of merging conference organizations as it creates a unified voice and reduces competition. Social Coordinator Moss who also chairs the NCAD conference discusses which organization(s) we could merge with. President Lupo inquires whether the board should consider merging the conference with a non-deaf organization versus with another Deaf organization.

Secretary Marshall suggests that a Parliamentary Procedures Training is offered during the conference, giving the attendees an opportunity to earn CEUs.

AGENDA TOPIC: NC DSDHH

According to the director of NC DSDHH, President Lupo relayed some concerns expressed by the community that NC Association of the Deaf did not immediately promote emergency information about hurricanes via social media (Facebook and monthly e-newsletters). President Lupo explains to Jan Withers, the director of NC DSDHH, that half of the board including the social media coordinator and the secretary was seriously impacted by Hurricane Helene – having no power, no water and no internet for over a week. The board agrees that there should be better "storm resiliency and response" to prevent catastrophic losses.

President Lupo explains that Jan Withers, Director of NC DSDHH, has asked the NCAD board to promote the FEMA: Federal Emergency Management Agency logo via social media.

Secretary Marshall inquires whether NC DSDHH could create a text alert system: an automated text message system that sends out mass texts to all Deaf, DeafBlind, Hard of Hearing and Late-Deafened consumers in affected areas. The purpose would be to deliver important emergency information.

In the past, the NC DSDHH director would attend our quarterly board meetings. When unable, a representative from NC DSDHH would attend in her place. Marshall Secretary inquires whether we could ask them to re-continue as maintaining an organizational relationship would improve collaboration and strengthen communication.

It was announced that the director of NC DSDHH, Jan Withers, will retire on February 1, 2025.
