19. Tuition Fees are non-refundable except in the case of class cancellation. If a class gets canceled, the tuition fee for that class will be carried forward for the next class/month.
20. If 50% of the students miss a class, then that class gets canceled or moved to a different day/date
21. Competition/Recital costume deposits are non-refundable. If your child’s recital/competition costume has been ordered you are responsible for the final balance of the costume even in the event that your child is no longer enrolled in the class.
22. Our Annual Recital ‘Kalolsavam’ will happen at the end of April or beginning of May timeframe.
23. We request parents/siblings not to be inside the dance class while the class is in progress as they are too much of a distraction to the students.
- 24. Dance attire and Hair along with items to bring for practice:**
  - a. Casual dresses like churidar or pajamas that is not too tight or loose
  - b. No shoes or socks. Practice done on bare foot
  - c. Hair must be pulled back and secure off face
  - d. Must have a dupatta scarf that usually tie against the waist
  - e. Must have a notebook and a pen
25. The fee for private or one-on-one classes may vary depending on the type of dance and the student's level of expertise.
26. No gum, food, or drinks allowed in the studio where students are dancing. Students may take a water bottle into class.
27. Classes will be held from August 2024 till May 2025 for 2024 – 2025 season
