1 thought, okay, I am going to give this the
2 benefit of the doubt, maybe he is under extreme
3 stress as a police officer in Milwaukee. He was
4 doing -- he had done undercover work. He had
5 done work with gangs and drugs and it was --
6 there was a lot of -- there was a lot going on
7 there.

8 So I agreed to this plan and we made
9 preparations to move to Steamboat Springs. Now
10 AAB wasn't even born yet at this point. She
11 was born January of 2008. So AAB was born and
12 things were not better with him at all by any
13 stretch of the imagination. He acted very
14 awkward and strange around her. I remember at
15 one point he would just like look at us from a
16 distance and just be very awkward and unpleasant.

17 The coffee mug incident happened.
18 That's a vivid memory I have of sitting on the
19 couch holding her. She was tiny. She was only a
20 couple weeks old at that point cradled in my arms
21 and he was of course trying to yell at me or say
22 I was lazy or whatever it was at that point and
23 ended up throwing a coffee mug at me from across
24 the room. Well it was probably because the
25 coffee mug wasn't where it was supposed to be so

1 that would have fit with his pattern of behavior.

2 Q. Did he hit you with the coffee mug?

3 A. I believe it hit me and not AAB
4 fortunately. That would've really been bad if it
5 had hit me -- her instead of me but, I mean, the
6 coffee splattered everywhere. That was my main
7 memory of it.

8 Q. Let's fast forward slightly.

9 A. Okay.

10 Q. Was there ever a time when he was more
11 physical with you? When he did something more
12 serious than throwing the coffee mug at you?

13 A. Well yes. On November 1st -- okay. So
14 I should say that we moved to Steamboat Springs
15 and things got a lot worse there. Things were
16 intensifying. The ride moving to Steamboat was a
17 grueling experience. It was a multi-day drive
18 with the three of us in a car and he sort of took
19 that as an opportunity to punish, torture.

20 He did things like turn the radio up as
21 loud as it would go. He would scream as loud as
22 he could in the car and I would say don't do this
23 in the car. I was very worried he was doing this
24 around AAB and of course she was a tinny baby
25 at that point. She was a couple weeks old and he

1. Plaintiff Heidi Brush, (Mother) and Defendant Leland Feldman, (Father) shall have shared legal custody of the minor child, [REDACTED] AAR [REDACTED] born [REDACTED] AAR [REDACTED]. Shared legal custody includes the following:

1. Legal Custody and Legal Custodial Responsibilities:

a. Major parental decisions concerning their child, including, but not limited to, their child's health, medical, dental & orthodontic treatment, mental health treatment, education, religious training and upbringing shall be made jointly by the parents, after discussion and consultation with each other, with a view toward obtaining and following a harmonious policy, in their child's best interest.

b. Each parent has the duty to obtain and is entitled to complete and full information from their child's doctor, dentist, teacher, professional or other authority and is entitled to have copies of any reports or information given to either parent, in accordance with 23 Pa.C.S.A §5309.

c. Each parent shall execute any and all legal authorizations so that the other parent may obtain information from their child's school, physicians, psychologists, or other individuals concerning her progress and welfare.

d. The parents shall reach a mutual agreement regarding the following matters: their child's enrollment or termination in a particular school or school program, advancing or holding their child back in school, authorizing enrollment in college, authorizing their child's driver's licenses or purchase of an automobile, authorizing employment, authorizing either child's marriages, enlistment in the armed forces, approving a petition for emancipation, authorizing foreign travel, passport application or exchange student status.

e. Any school district in which the child attends school shall provide both parents identical information. The custodial parent shall provide to the non-custodial parent on a weekly basis,

all school papers, projects, or other products of the child's development, so as to allow a sharing of those items as fully as possible.

f. Neither parent shall impair the other parent's rights and responsibilities for their shared legal custodial responsibilities for their child.

2. Mother shall have primary physical custody of the minor child, with Father to have supervised visitation every other Saturday as arranged through the Centre County Child Access Center.

3. The parties shall agree on a Maryland therapist for the child. The therapist may have contact with both parties and collateral sources.

4. Counsel for the parties are permitted to submit a letter of background information without attachments to the therapist and shall exchange said letters with each other.

5. Father shall be permitted to Skype with the child as follows:

a. On Thursday, January 2, 2014 at 7:00 p.m. Eastern Standard Time.

b. On Tuesday, January 7, 2014 and Thursday, January 9, 2014 at 7:00 p.m.

c. On Tuesday, January 14, 2014; Thursday, January 16, 2014; and Saturday, January 18, 2014 at 7:00 p.m. Father shall then be able to Skype with child every Tuesday, Thursday, and Saturday thereafter at 7:00 p.m.

6. The parties shall exchange email addresses by January 1, 2014 for limited emailing concerning the child and for Skyping.

7. The parties agree that the following witnesses may appear by phone in the event that a custody hearing becomes necessary; Laura Johnson, Linda Bannier, Aaron Feldman, and Jill Fraser.

8. A custody conference is scheduled for April 11, 2014 at 1:00 p.m. in Room 206 of the Centre County Courthouse, Bellefonte, Pennsylvania.
